***\*\*The portion of the payment used for a PAC contribution (\$25) is not deductible for income tax purposes. Contributions to RPAC are voluntary and are used for political purposes. You may refuse to contribute without reprisal or disfavor. You can deduct the \$25 from the total amount if you wish not to contribute. 70% of each contribution is used by MARPAC to support state political candidates. 30% of personal contributions are sent to National RPAC to support federal candidates and is charged against limits under 2 U.S.C. 441a; and if corporate contribution, 30% is sent to the NAR Political Action Fund.***
